JUDGMENT

Action Filing Date: March 6, 2003

On December 7, 2007 at 8:30 a.m. in Department 62 of the above-entitled Court, the Hon. Michael L. Stern, Judge Presiding, this matter was called for hearing to present evidence in support of Plaintiff Michael Flatley's Request for Default Judgment against Defendant Tyna Marie Robertson. Ms. Robertson was properly served with a copy of the Summons and Complaint, she failed to appear in the action and her default was entered on October 12, 2004. Plaintiff Michael Flatley was represented at the hearing by Ricardo P. Cestero, Esq. of Greenberg Glusker Fields Claman & Machtinger LLP.


JUDGMENT

1 Mr. Flatley was sworn and testified in support of his causes of action for Defamation
2 and Intentional Infliction of Emotional Distress. Mr. Flatley testified to the importance of his
3 reputation to his business and the impact of Robertson's false claims on Mr. Flatley's personal
4 life. Mr. Flatley further testified to the negative impact these claims had on his business, to
5 revenue lost as a result of publicity surrounding these false claims and to the emotional distress
6 and mental suffering incurred as a result of being faced with these false claims.


7 The Court, having considered Mr. Flatley's testimony presented at the hearing, papers
8 filed in support of the Request for Default Judgment and the previously filed declarations and
9 prior proceedings in the action which conclusively establish the falsity of Robertson's claims
10 and Robertson's malicious, intentional and willful publication of these false accusations, the
11 Court finds adequate support for an award of damages against Ms. Robertson on the causes of
12 action for Defamation and Intentional Infliction of Emotional Distress.

13 Accordingly, it is hereby ORDERED, ADJUDGED and DECREED that Plaintiff
14 Michael Flatley recover from Defendant Tyna Marie Robertson damages in the amount of
15 \$11,095,872 on his causes of action for Defamation and Intentional Infliction of Emotional
16 Distress.
