AFFIDAVIT OF ANDREW BEHR

19 I, Andrew Behr, sworn to testify under oath, state the following:

20 1. I am individual over the age of 18 and am competent to testify if called as a witness. I
21 have first-hand knowledge of the facts stated in this affidavit.

22 2. At no time in 1989 or 1990 did Ron Ramsdell live in our house. My oldest brother
23 John still lived at home with in 1989 and 1990 and Ron did not move into our house while John still
24 lived there.

25 3. I didn't even know Ron during that time period. During 1989 and 1990, my mother
26 was still in a relationship with Bob Lee, who was a really cool guy and good to me.

27 4. In 1992, I was 12 years old. On May 20th, 1992 I was home from school because I
28 was sick. I heard my mother and Ron fighting in the upstairs bedroom and then went upstairs to help

1 my mother. I saw Ron grabbing my mother violently by the arms and thrusting her body against the
2 wall. I told Ron to get away from my mother; when he would not stop banging her against the wall I
3 pushed him off of her and then he punched me in the face and pushed me down onto a glass table.

4 5. As this occurred, my mother ran downstairs to get away from Ron. Ron chased her
5 down the stairs and into the family room. As this was happening, I then went downstairs to my room
6 and used the cordless phone to call 911. As I was on the phone with the 911 operator, explaining
7 how Ron was beating my mother, I picked up my BB gun and went into the family room doorway.
8 While still on the phone with the 911 operator and looking into the family room, I saw Ron kneeling
9 on my mother and pinning her to the floor, choking her with his hands while banging her head
10 against the floor. I thought he was going to kill my mother, and I told the 911 operator that I was
11 going to shoot him with the BB gun to stop him. I then shot him in the shoulder while still on the
12 phone with the 911 operator.

13 6. I hit Ron in the shoulder with the shot. He looked up at me and started to get off my
14 mother to come towards me. At that moment, the police came through the family room door and
15 restrained Rom from attacking me again. The police then arrested Ron, took him into custody and
16 took my mother to the hospital in an ambulance.

17 7. I was only 12 when this happened yet he thought nothing of punching a little kid or
18 trying to kill my mother right in front of me. I think Ron is a very disturbed and dangerous man.

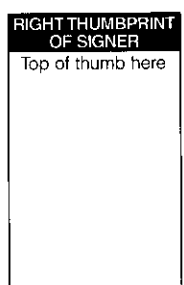
