I hereby certify that this information ^{BY} ^{DEPUTY CLERK} is accurate to the best of my knowledge:

On 4-30-08 after evening dinner at approx. 4:40 pm. Several inmates were discussing what to do about our trays not being equally proportioned while the guards in the pod control area - which include Dep. Collins, Dep. Wells, Dep. Wright, Dep. Switzer, and Dep. Bennett, - were making jokes towards the situation (Ex "What is the problem guys did we over feed you all again" in the background you hear laughter). Sergeant Vaughn, Sergeant Torres, Sergeant Carleton, and Sergeant Robbins pulled me out of the pod away from any witnesses and yelled at me harassed me and just assumed I was the inmate that started this situation. They also threatened to place me in lockdown for 30 days for inciting a riot. Sergeant Vaughn informed me that Captain Petray said "If I hear any thing at all again about Inmate Laswell (myself) I will place him in administrative segregation". While I was eating several other inmates discussed how to go about informing the jail staff about the small and unfair sized proportions. They were doing so in an orderly manner however a couple of inmates were speaking in a loud tone to insure they were heard over others talking. This is not in any way trying to start a riot. These guards have started to harass me alot now. The following day I was placed on Administrative Segregation. They did this for harrasment purposes only! Several inmates informed the sergeants ~~me~~ that I did not cause the disturbance. They still placed me on AD. Spg. In the Inmate handbook It states that "The Inmate side of the story will be heard before any ^{cont} →

discipline actions will be taken". Why did I not get to share my side of the story? Why was I disciplined before an investigation was done? I am being harassed that's all there is to it. I hereby request to have the Honorable James R. Marschewski order a speedy transport to ADC (Arkansas Department of Corrections) to start my sentence from Washington County on case # CR 2006-2559 and CR 2006-1976. I feel like I am no longer safe in here, and I should not have to be harassed like this.
