

The plaintiff, by his attorney STEPHAN PERSOFF, ESQ., complaining of the defendant alleges as follows:

1. That the plaintiff is a resident of the County of New York, State of New York, residing at 15 Broad Street.
2. That the defendant is a domestic corporation with a principal place of doing business in the County of New York, State of New York.
3. That the defendant operates an adult entertainment club known as the Hot Lap Dance Club in various venues within the County of New York, State of New York.
4. That on November 2, 2007, at approximately 1:00 a.m., the plaintiff was a patron at the defendant's club at a location known as 344 West 38<sup>th</sup> Street, New York, New York.
5. That during the course of the evening of said date, the plaintiff paid for and was receiving a lap dance from an employee of the defendant.

6. That during the course of said lap dance, the employee suddenly swung around, striking the plaintiff in the eye with the heel of her shoe.


7. That as a result of the aforementioned, the plaintiff sustained serious personal injuries.
